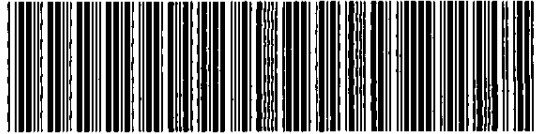

We, the undersigned natural persons of the age of twenty-one years or more acting as  
Incorporators of non-profit corporation adopt the following Articles of Incorporation for  
such corporation pursuant to the State of Florida Non-Profit Corporation Act

## Article I

**The name of Corporation shall be:**

otherwise dispose of any such property and to invest, reinvest or deal with the principal of income therefore in such a manner, as in the judgment of the directors, will best promote the purposes of the Corporation without limitation, except such limitations, if any, as may be contained in the instrument under which property is received, the Articles of Corporation, the By-Laws of the Corporation, or any laws applicable thereto.

- (3) To do any other act or thing incidental to connected with foregoing purposes or in advancement therefore, but not for the pecuniary profit of financial gain of its directors or officers except as permitted under the State of Florida Non-Profit Corporation Act.
- (4) Notwithstanding any provisions of these articles, these purposes are limited to those described in Section 501 (c)(3) of the Internal Revenue Code of 1954 or any other corresponding provision of any future United States Internal Revenue Code.
