ARTICLE III

The specific purpose for which this corporation is organized is:

The organization is organized exclusively for charitable, religious, and educational purposes, including, for such purpose, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE VIII

Term of Existence, Operation and Dissolution:

This organization shall have perpetual existence.

The organization shall have and enjoy all of the powers set forth in the Florida Statutes for Not For Profit corporations, including but not limited to the right to acquire, sell, convey, mortgage, lease, exchange, transfer or otherwise dispose of all or any part of its property and assets, including the right to borrow or otherwise become indebted without limitation as to amount. All of the affairs of said corporation shall be administered according to its Constitution and Bylaws.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal taxe code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets nor disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
