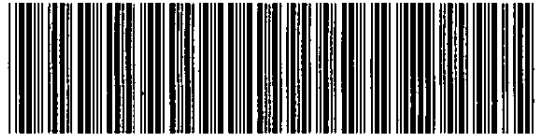

No part of the net earnings of the corporation shall be to the benefit of, or be distributable to its members, trustees, officers, directors, or other private persons except as reimbursement for expenses incurred on behalf of the corporation in its stated cause.

Upon dissolution of the corporation, any remaining funds or assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.


