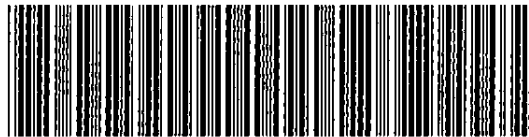

ARTICLE I NAME

The name of the corporation shall be: **ProNet Career Resources, Inc.**

ARTICLE II PRINCIPAL OFFICE

The principal street address and mailing address is: **246 Hanging Moss Circle
Lake Mary, Florida 32746**

ARTICLE III PURPOSE

The purpose for which the corporation is organized is: **The corporation is organized exclusively for charitable, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code.**

ARTICLE IV NOT FOR PROFIT ACTIVITIES

The not for profit activity requirements are: **No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, trustees, officers or other private persons. The corporation shall be authorized and empowered to pay reasonable compensate for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III, hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) an political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section in any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section in any future federal tax code.**

ARTICLE V DISSOLUTION

The requirements for dissolution are: **Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section**

501(c)(3) of the Internal Revenue Code, or the corresponding section in any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE VI MANNER OF ELECTION

The manner in which the directors are elected or appointed is: The directors will be appointed or selected by the existing executive board of directors based on the individual member's interest, skills and qualifications necessary to fulfill the duties of director.
