ARTICLES OF INCORPORATION

The undersigned natural persons, having the capacity to contract and acting since the incorporators of a corporation under Florida Statutes, Chapter 617, adopts the foligining articles of incorporation.

ARTICLE I

The name of the corporation is: AFRICAN CONNECTION, INC.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose of the corporation is as follows:

- The specific and primary purposes of this corporation shall include, but are not limited to, empowering the under-privileged children to live a responsible life, operating of orphanages, educational centers, seminars and workshops, educating children and needy people to make healthy choices, and equipping national leaders for effective leadership in developing nationals of Africa.
- 2. To do everything necessary, suitable, or proper for the accomplishment, attainment, or furtherance of (and to do every other act or thing incidental to, pertinent to, growing out of, or connected with) the purposes, objects, or powers set forth in these Articles, whether alone or in association with others; to possess all the rights, powers, and privileges now or hereafter conferred by the laws of the State of Florida upon a nonprofit corporation organized under the laws of the State of Florida; and, in general, to carry on any activities and to do any of the things herein set forth to the same extent as a natural person or partnership might or could do; provided that nothing herein set forth shall be construed as

authorizing the corporation to possess any purpose, object, or power to do any act or thing forbidden by law to a nonprofit corporation organized under the laws of the State of Florida.

ARTICLE IV LIMITATIONS

The corporation is organized exclusively for religious and charitable purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986 and its Regulations as they now exist or as they may hereafter be amended (or the corresponding provision of any future United States Internal Revenue law and its Regulations).

- 1. No part of the income of the corporation shall inure to the benefit of, or be distributable to, its directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article VII hereof.
- 2. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements relating to), any political campaign on behalf of any candidate for public office.
- 3. Notwithstanding any other provisions of these Articles, the corporation shall not conduct or carry on any other activities not permitted to be conducted or carried out by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 and its Regulations, as they now exist or as they may hereafter be amended (or the corresponding provision of any future United States Internal Revenue law and its Regulations); or by a corporation, contributions to which are deductible under Section 170 (c)(2) of the Internal Revenue Code of 1986 and its Regulations, as they now exist or as they may hereafter be amended (or the corresponding provisions of any future United States Internal Revenue Law and its Regulations).

ARTICLE V

MANNER OF ELECTION of DIRECTORS/MEMBERS

A: The Board of the corporation shall be a self-perpetuating Board, which shall consist of no less than five (3) members who shall be elected for terms varying from one (1) to three (3) years. Any out-going member may be re-elected. All Board Members while sitting in official sessions shall have equal voice and vote regardless of the office or

position held. No one except the President shall serve as African Connection personnel while holding a position on the Board.

B: The Board shall:

- 1. Establish policy.
- 2. Elect a Secretary.
- 3. Retain ultimate responsibility and authority for the Corporation.
- 4. The Board shall serve as Trustees for all corporation property.

C. The management and affairs of the corporation shall be at all times under the direction of a Board of Directors, whose operations in governing the corporation shall be defined by statute and by the corporation's by-laws. No Director shall have any right, title, or interest in or to any property of the corporation.

Any such assets not so disposed of shall be disposed of by a court of appropriate jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes.
