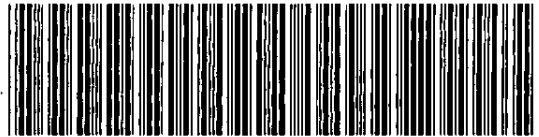

ARTICLE ONE

NAME

The name of this corporation is: VOLUSIA TRAIL RIDERS, INC., A FLORIDA NON-PROFIT CORPORATION.

ARTICLE TWO

PRINCIPAL OFFICE AND ADDRESS

The address of the principal office of the corporation is 667 Arnau Drive, New Smyrna Beach, Florida 32168 and the mailing address is P.O. Box 845, New Smyrna Beach, Florida 32170.

ARTICLE THREE

PURPOSE

This corporation is organized and operated exclusively for the following exempt purposes: To bring together off-highway vehicle enthusiasts to enjoy, promote and protect responsible OHV recreation activities.

- a. To conduct club rides and campouts.
- b. To help maintain and monitor local trails.
- c. To participate in local OHV area volunteer projects.
- d. To help promote youth-oriented OHV training programs.
- e. To teach environmental responsibility of land use during OHV activities.
- f. To insure responsible outdoor ethics and safety to improve the image of OHV activities in the community.

ARTICLE FOUR
DIRECTORS & OFFICERS

The affairs of this non-profit corporation are to be managed by a President, Vice, President, and Secretary and other such directors as the Board of Directors deem advisable. These directors shall be elected annually by the membership in the manner prescribed by the by-laws.

ARTICLE FIVE.
REGISTERED AGENT

Said corporation is organized exclusively for charitable, education, religious or scientific purposes within the meaning of Section 501C3 of the Internal Revenue Code (or corresponding section of any future federal tax code).

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except


that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501C3 purposes. No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distributing of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501C3 of the Internal Revenue Code (or corresponding section of any future federal tax code).

Upon dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501C3 of the Internal Revenue Code, i.e., charitable, education, religion or scientific, or the corresponding section of any future federal tax code, or shall be distributed to the federal government or to any state or local government for a public purpose.

However, if the named recipient is not then in existence or no longer a qualified distributee, or unwilling to accept the distribution, the assets of this corporation shall be distributed to a fund, foundation or corporation organized and operated exclusively for the purposes specified in Sections 501C3 of the Internal Revenue Code (or corresponding section of any future federal tax code).


