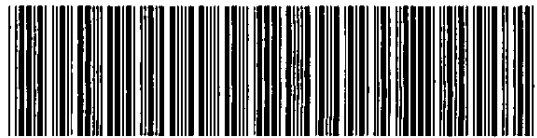

Article IX entitled Board of Directors is hereby amended as follows: Paragraph C(2) is hereby amended to read as follows: Four months after 75% of the Units that will be operated ultimately by the Association have been conveyed to Purchasers.

Paragraph C(5) is hereby amended to read as follows: Three months after 90% of the Units that will be operated ultimately by the Association have been conveyed to Purchasers.

A new Paragraph C(6) shall be added as follows: For FHA purposes. Five (5) years after recordation of the Declaration of Condominium in the public records; or in the case of an Association, which may ultimately operate more than one condominium, five (5) years after recordation of the Declaration for the first Condominium it operates; or, in the case of an Association operating a phase Condominium created pursuant to Florida Statute 718.403, five (5) years after recordation of the Declaration creating the initial phase, whichever occurs first.

A new Paragraph C(7) shall be added as follows: When the developer files a petition seeking protection in bankruptcy.

A new Paragraph C(8) shall be added as follows: See Page 3 attached hereto.

Paragraph C(8): When a receiver for the developer is appointed by a circuit court as is not discharged within thirty (30) days after such appointment.
