ARTICLES OF INCORPORATION OF ARCHANGEL RAPHAEL FOUNDATION, INC., A FLORIDA NOT-FOR-PROFIT CORPORATION

The undersigned hereby subscribes these Articles of Incorporation for the purpose of organizing a not-for-profit corporation, under the laws of the State of Florida.

I. Name

The name of the Corporation is ARCHANGEL RAPHAEL FOUNDATION, INC., (the "Foundation").

II. Purpose

The purpose of the Foundation shall be to conduct all business that a FLORIDA NOT-FOR-PROFIT CORPORATION can conduct under the laws of the State of Florida.

III. Membership

All persons interested in the purposes of the Foundation are eligible for membership in the Foundation, if they are capable of contributing to the achievement of those purposes and the effective operation of the Foundation, and if they comply with the requirements established from time to time in the Bylaws. Members shall have no voting rights or other rights, except as provided in the Bylaws.

IV. PRINCIPAL OFFICE

The mailing and street address of the Foundation's principal office shall be:

V. REGISTERED AGENT AND REGISTERED OFFICE

VI. Limitations

No part of the net earnings of the Foundation shall inure to the benefit of (or be distributable to) its directors, officers, members or other private persons, except that the Foundation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions, in furtherance of any of its purposes. No substantial part of the activities of the Foundation shall be the carrying on of propaganda or otherwise attempting to influence legislation, except as otherwise provided in Code Section 501(h), as amended. The Foundation shall not participate or intervene in any political campaign (including the publishing or distributing of statements), on behalf of any candidate for public office. Notwithstanding any other provision of these Articles of Incorporation, the Foundation shall not carry on any activities except those permitted to be carried on by a corporation exempt from federal income tax, under Code Section 501(c)(3), as amended, and which entitle contributors to the Foundation to deduct their respective charitable contributions under Code Section 170(a), as amended.

If the Foundation is at any time deemed to be a private foundation within the meaning of Code Section 509(a), as amended, then for the period in which the Foundation is so deemed, the Foundation shall distribute its income for each tax year at such time and in such manner as not to subject the Foundation to tax under Code Section 4942, as amended, and the Foundation shall not engage in any act of self-dealing as defined in Code Section 4941(d), as amended, retain any excess business holdings as defined in Code Section 4943(c), as amended, make any investments as to subject the Foundation to tax under Code Section 4944, as amended, or make any taxable expenditures as defined in Code Section 4945(d), as amended.

X. CORPORATE EXISTENCE

The corporate existence of the Foundation shall begin effective as of August 4th, 2009, and be perpetual.
