ARTICLES OF INCORPORATION OF

New Shady Grove Missionary Baptist Church, Inc.

A Florida "Not for Profit" Corporation

The undersigned, acting as incorporator of a corporation under Chapter 617 of Florida Statutes, adopts the following Articles of Incorporation:

- A. NAME OF CORPORATION: The name of the corporation is New Shady Grove Missionary Baptist Church, Inc.
- **B.** PRINCIPAL OFFICE: The principal office of the corporation is located at 9225 SW 27th Ave Ocala, FL 34476-7582
- C. MAILING ADDRESS: The mailing address of the corporation is 9225 SW 27th Ave Ocala, FL 34476-7582.
- D. REGISTERED AGENT: The name of the registered agent of the corporation is Edna Simmons. The address of this registered agent is 9225 SW 27th Ave Ocala, FL 34476-7582.
- E. DURATION/MEMBERSHIP: The period of duration is perpetual. The qualification for members, if any, and the manner of their admission shall be regulated by the bylaws.
- **F. BOARD OF DIRECTORS:** The method of selection of the Board of Directors and number of directors shall be stated in the bylaws.
- 1. The names and address of the persons who are to serve as the initial directors/officers until the election of their successors are:

- G. INCORPORATORS: The name and address of the incorporator is: Marvin Borders, 11254 SW 76th Terrace; Ocala, Florida 34476.
- H. CORPORATE PURPOSES: The purposes for which this corporation is formed are exclusively charitable, religious, and educational and consist of the following:
 - 1. This corporation is formed exclusively for charitable and educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
 - 2. To aid, support, and assist by gifts, contributions, or otherwise, other corporations, community chests, funds and foundations organized and operated exclusively for charitable or educational purposes, no part of the net earnings of which inures to the benefit of any private shareholder or individual, and no substantial part of the activities of which is carrying on propaganda, or otherwise attempting to influence legislation.
 - 3. To do any and all lawful activities which may be necessary, useful, or desirable for the furtherance, accomplishment, fostering, or attaining of the foregoing purposes, either directly or indirectly, and either alone or in conjunction or cooperation with others, whether such others be persons or organizations of any kind or nature, such as corporations, firms, association, trusts, institution, foundations, or governmental bureaus, departments or agencies.
 - 4. All of the foregoing purposes shall be exercised exclusively charitable and educational purposes in such a manner that the Corporation will qualify as an exempt organization under section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

I. 501(c)(3) LIMITATIONS

- 1. CORPORATE PURPOSES: Notwithstanding any other provision of these articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal and state income tax under section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- 2. **EXCLUSIVITY:** The Corporation is organized exclusively for charitable and educational purposes.
- 3. NO PRIVATE INUREMENT: The Corporation is not organized nor shall it be operated for the primary purpose of generating pecuniary gain or profit. The Corporation shall not distribute any gains, profits or dividends to the Directors, Officers, or Members thereof, or to any individual, except as reasonable compensation for services actually performed in carrying out the Corporation's charitable and educational purposes. The property, assets, profits and net income of the Corporation are irrevocably dedicated to charitable and educational purposes no part of which shall inure to the benefit of any individual.
- 4. LOBBYING AND POLITICAL CAMPAIGNS: No substantial part of the activities of the corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in, any political campaign on behalf of any candidate for public office.
- 5. DISSOLUTION: Upon winding up and dissolution of the Corporation, the assets of the Corporation remaining after payment of all debts and liabilities shall be distributed to an

organization recognized as exempt under section 501(c)(3) of the Internal Revenue Code of 1986 to be used exclusively for charitable and educational purposes. The remaining assets of the corporation shall be distributed for one or more of the exempt purposes of the corporation to one or more organizations which are exempt organizations described in Section 501(c)(3) and 170 (c) (2) of the Internal Revenue Code or any other corresponding sections of any future federal tax code.

J. BYLAWS

The power to adopt, alter, amend or repeal bylaws shall be invested in the Board of Directors in the manner provided by the bylaws of the New Shady Grove Missionary Baptist Church, Inc.

K. AMENDMENTS

The corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation or any amendment thereto.
