
In the past your assistance has proven to be a tremendous asset, and I do thank you for all of your help.

The purpose for which the corporation is organized is:
South Florida Kids Choir, Inc. is an independent non-profit organization founded in order to teach and encourage excellence in quality choral music. Its primary purpose is to provide a unique and unsurpassed level of music education. South Florida Kids Choir, Inc. will be comprised of many choirs. It will contract with organizations seeking to create "City" choirs throughout South Florida (Dade, Broward, and Palm Beach Counties) to offer musical training and performance opportunities to singers ages 10-18 (in choral groups) and all ages (individual and corporate group vocal training).

ARTICLE IV MANNER OF ELECTION

ARTICLE VIII DISSOLUTION

South Florida Kids Choir, Inc. is organized exclusively for charitable and educational purposes, including, for such purpose, the making of distributions to organizations that qualify as exempt organizations under

section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

South Florida Kids Choir, Inc. shall be a corporation which does not contemplate pecuniary gain or profit to the members thereof, nor the distributions of gains, profits or dividends to such members, and no part of the net earnings of the association shall inure to the benefit of any of its members or any other private individual.

In the event of the dissolution of South Florida Kids Choir, Inc., after paying or adequately providing for its debts and obligation, the Board of Directors shall devote any remaining assets to carry out one or more of the purposes of the organization, if feasible, and if not, the Corporation's net assets shall be distributed to any one or more non- profit funds, foundations, corporations or associations organized and operated solely for charitable and educational or other eleemosynary purposes, and which have established their tax exempt status under Section 501 (c) (3) of the Internal Revenue Code, and if South Florida Kids Choir, Inc. holds any assets in trust, such assets shall be disposed of in accordance with the Non- Profit Corporation Law of the State of Florida.

Having been named as registered agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity.
