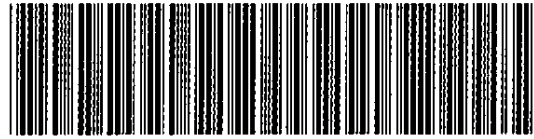

ARTICLES OF INCORPORATION
FOR
UPLIFT LIFE FOUNDATION, INC.
A FLORIDA NON - PROFIT CORPORATION

The undersigned, acting as incorporator (s) of a corporation pursuant to Chapter 617, Florida Statutes, adopt (s) the following:

ARTICLE I, NAME

The name of the corporation shall be UPLIFT LIFE FOUNDATION, INC.

ARTICLE II.

PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

*Principal place of business shall be 2718-B Lee Blvd. Lehigh Acres, Florida 33971,
And the mailing address is Post Office Box 125; Fort Myers Fl 33902*

ARTICLE III. PURPOSE (S)

This corporation is organized for charitable and educational purposes within the meaning of Section 501 © (3), of the Internal Revenue Code (or the corresponding portions of any future United States Internal Revenue Law), including, to the extent permitted by said Section 501 © (3), the redevelopment, support, up-grading, and rehabilitation of the national, and economic aspects of Lee County, Florida, and its environs.

No substantial part of the activities of the Corporation shall be the carrying on propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distributing of statement) any political campaign on behalf of any candidate for public office.

This Corporation is and shall remain a corporation not for profit. The Corporation shall be paid, and no part of the net earnings of the Corporation shall inure to the benefit of its members, directors or offices, or to the benefit of any private shareholder or individual.

ARTICLE IV.

MANNER OF ELECTION OF DIRECTORS

The President, Vice President and CEO shall appoint the Directors or Advisers.

ARTICLE VI. TERM OF EXISTENCE

"Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law)."

ARTICLE VII. BY - LAWS

Section One: The Board of Directors key purpose of the By-Laws is to ensure the foundation's success by collectively directing the foundation's affairs whilst meeting the appropriate interests of its foundation contributes.

Section Two: The By-Laws may be repealed or amended, and new By - Laws may be adopted, by the Board of Advisors

ARTICLE VIII.

DISTRIBUTION OF ASSETS UPON DISSOLUTION

"Upon winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to a non-profit fund, foundation, or corporation which is organized and operated exclusively for charitable, educational, religious, and or scientific purposes and which has established, its tax exempt status under section 501(c)(3) of the Internal revenue Code.

ARTICLE IX. AMENDMENTS

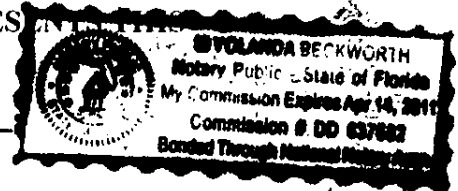
