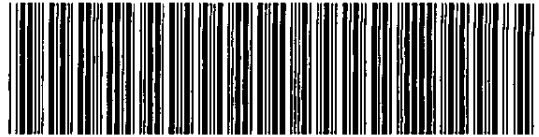

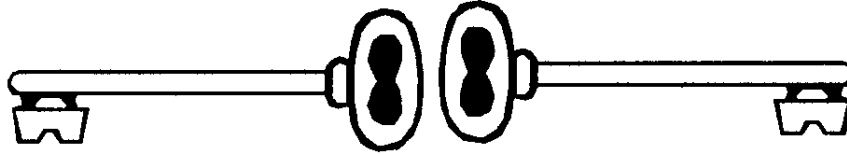

ARTICLE I

The name of the corporation is: **Advocacy For American Seniors Association, Inc.**

ARTICLE II

5614 Brookdale Way, Tampa, Florida 33625

ARTICLE III

The purpose for which the corporation is organized is the transaction of any or all-lawful business for which corporation may be incorporated under the Florida Corporation Act.

- A. To encourage suitable development of civic improvements in the Communities in the State of Florida, and its allied states;
- B. To promote, advertise and do all things conducive to the development of the Communities in the State of Florida and its allied communities through voters registration and education;
- C. To promote a spirit of cooperation between the communities activist organizations in State of Florida and others communities;
- D. To promote healthcare available to American Seniors through their voting rights process;
- E. To promote community interest, encourage travel, and advertise recreational and political awareness opportunities for American seniors;
- F. To provide for seniors the education and entertainment of the community by providing and operating television translator facilities;
- G. The Advocacy For American Seniors Association, Incorporation, strong and diverse membership will represent a wide spectrum of American Seniors;
- H. To plan details and perform activities and services, which are supportive of cultural, social and political progress in the awareness of the community through news media;
- I. To direct, supervise, participate in individual and group travels for seniors;

- J. To organize and associate with groups, corporations, person, fraternities, sororities, societies or entities which have or may have similar goals and objectives that promotes seniors awareness and well being;
- K. To be a unique corporation which will effectively advance seniors awareness within their community and its allied communities by way of print, electronic, and audio media;
- L. Receive financial support from foundations, corporations, governments; religion institutions, unions, individuals, political groups, organizations and a broad section of the United State citizens who believes that America can and should become truly interracial by way of association opportunities;
- M. To be a nonpartisan corporation, which fosters cultural participation at all, levels in order to build a more cohesive, responsive, and representative system within our communities in the State of Florida;
- N. To be of assistance to community-based organizations through the news media print, audio, or electronic;
- O. To provide travel assistant to individual(s) or group(s) for political awareness;;
- P. To provide public and private information through research to individual(s) or group(s) by way of consulting services;
- Q. To learn how to lobby public and private individual(s) or group(s) for issue awareness on behalf of the American Seniors;
- R. To venture into joint projects for voters registration and education;
- S. To venture into joint projects dealing with communities inside and outside the State of Florida;
- T. To venture into private and public research opportunities;
- U. To train and support individual(s) or group(s) in personal computers for their senior organization.

ARTICLE IV - MANNER OF ELECTION

The manner in which the Directors are elected will be by appointment by the four (4) founding directors or sitting directors at time of new directors. The Board of Directors shall appoint all *Advisory committee Directors and committee members* by a 3/4 vote of the Board of Directors.

ARTICLE V – INTIAL DIRECTORS AND OFFICERS

The number of officers constituting the initial organization are four (4) Directors, and the names and addresses of the person or persons who are to serve as President, 1st Vice-Presidents/Treasurer, and 2nd Vice-Presidents, Secretary until the first annual meeting of the newly form group.
