ARTICLE II - PURPOSE

Divine Restoration Ministries, Inc. is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations described under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. Additionally, Divine Restoration Ministries, Inc., is to carry out the Will, Purpose and Plan of God and to provide a place where the lost can meet Jesus Christ and accept Him as Lord and Savior and to spread spiritual growth and Christian truth to Church members, believers, the community and mankind. The Church's purpose and mission is also to assist its members, believers, community and world to abide by the Scriptures in the Holy Bible; to worship God in spirit and truth; to love others by meeting their needs and healing their hurts; and assisting its members, believers and the community to evangelize individually and collectively.

The Church offers and provides the hurting, frustrated and confused love, acceptance, help, hope, forgiveness, guidance and encouragement. The Church shares the good news of Jesus Christ with our community and the world.

The Church welcomes all persons to fellowship in love and learning in harmony the sound doctrines contained in the Holy Bible. The Church will promote spiritual maturity to it members and believers and will assist those by helping discover their spiritual gifts and talents.

Additionally, the Church will educate its members and the community in sound Christian doctrine; to be a worshipping fellowship that minister to the community and the world in the name of Jesus Christ; and to educate its members, community and believers to be Christlike in character, conduct and conversation.

Furthermore, the Church will educate its members and believers spiritually and in other matters and develop educational programs that will enhance the spiritual growth of its members and believers. The Church's goal is to restore faith in families in their finances and an assurance of fulfillment to the imprisoned, fortunate and unfortunate, believers and non-believers through the teaching of God's Holy Word and spiritual guidance.

The Church seeks to establish a Day Care Program; Outreach Program; Church School; Educational Facility; Recreational Facility; build a Worship Center; Fellowship Hall and accessories to accommodate the present and future needs of the Church and the community; establish, maintain and support a Ministry of Brotherhood and other ministries to meet the needs of the Church and the community and further the spiritual and overall growth of its members and believers, and will promote ministries to promote a systematic study of Scripture, sound doctrines of faith, the advancement of biblically oriented mission ministries and the enrichment of nurturing ministries for individual maturity.

The Church also is authorized, according to its by-laws, to receive, administer, disburse, use or invest gifts, devises and bequests by any person or corporation, and to issue bonds, notes, debentures and evidence of indebtedness, and secure same by mortgage deed of trust or otherwise. The Church's other general purpose(s) are set forth in the Church's Constitution and By-laws.
