TO THE  
ARTICLES OF INCORPORATION OF  
LARRY BENDER MINISTRIES, INC.**

Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following amendments to its Articles of Incorporation:

**ARTICLE III  
Purposes**

The General Purposes for which said corporation is organized are exclusively for charitable, religious, literary, scientific and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The specific purposes for which the corporation is organized are providing a place of worship for its members, who shall be members in good standing and conducting the affairs of the corporation according to the rules, regulations and bylaws of Larry Bender Ministries; promoting the cause of Christianity; receiving, managing, and disbursing gifts, bequests, and other funds for the benefit of the ministry, owning and maintaining suitable buildings and facilities necessary for their acquisition, upkeep, maintenance and sale, all in accord with the rules, regulations and bylaws of the corporation.

This corporation is organized and operated exclusively for non-profit purposes and no part of any net earnings shall inure to the benefit of any member, director or officer.

Notwithstanding any other provision of the Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code) or (b) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code (or corresponding section of any future tax code).


Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

The date of the amendment of Article III is March 1, 2010.

There are no members entitled to vote on the amendment. The amendment was adopted by the Board of Directors.
