CERTIFICATE OF ADMINISTRATIVE DISSOLUTION

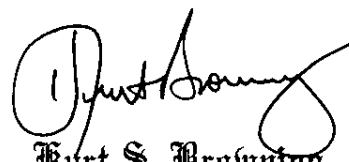
