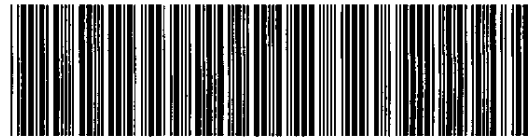

The purpose for which the corporation is organized is:

The purpose of M&A Center For Hope are:

1. To worship God, who is worthy of all praise and glory.
2. To serve God locally, nationally, and internationally by fulfilling the Great Commission of Jesus Christ as set forth in Matthew 28:19-20
3. To minister to the needs of the members and others as the church is able to do so.
4. To do any and all things related to and in connection with the carrying out of the purposes of the Old and New Testament.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

All membership meetings at which elections for vacant board seats are to occur shall be adequately publicized within the Corporation's service area.

An ample opportunity shall be given to all service area residents to become members of the corporation and thus, participate in the election process.

At all membership meetings, each member shall have the right to vote for as many nominees as there are vacancies in the board of directors.

The top vote getters shall fill the vacant seats (e.g. if there are five vacancies, the top five vote getters shall serve on the board.)

Selection in the case of a tie shall be by a run-off between the individuals who ended up tied.

M&A Center for Hope Ministries shall license and ordain ministers of the gospel. The Board of Director shall determine licensure or ordainment with top vote for vacant seat.
