No part of the net earnings of the corporation shell inure to the benefit of, or to be distributable to, its members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay a reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in article three hereof. No substantial part of the activities of the corporation shall be the carrying on a propaganda, or otherwise attempting to influence legislation, and the corporation shall not purticipate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501 (c)(3) of the internal revenue code of 1954 (or the corresponding provision of any future United States internal revenue law) or (b) by a corporation, contributions to which are deductible under section 170 (c)(2) two of the internal revenue code of 1954 (or the corresponding provision of any future United States internal revenue law).

Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities are exercise any powers that are not in furtherance of the purposes of this corporation.

Upon dissolution of the corporation, the board of director shall, after paying or making provision for the payment of all the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational or religious purposes as shall at the time qualify as an exempt organization or organizations under section 501 (c) (3) of the internal revenue code of 1954 (or the corresponding provision of any future United States internal revenue law), as the board of directors shall determine.

Any such assets not so disposed of shall be disposed of by the court of common pleas of the county in which the principle office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
