ARTICLE III PURPOSE

- (3) The Corporation is irrevocably dedicated to, and operated exclusively for, nonprofit purposes set forth in this Article III; and no part of the income, assets, or net earnings of the Corporation shall inure to the benefit of, or be distributed to, directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise trying to influence legislation, and the Corporation shall not participate in, or intervene (including the publication or distribution of statements), in any political campaign on behalf of any candidate for public office. Notwithstanding any other provisions of these articles, this Corporation shall not carry on any other activities not permitted to be carried on:
- (a) by a corporation exempt from federal income tax under Section 501(c) (3) of the Code, or
- (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Code.
