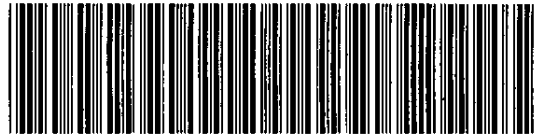

### ARTICLE I — NAME

The name of the corporation shall be: **Jesus Dollars, Inc.**
