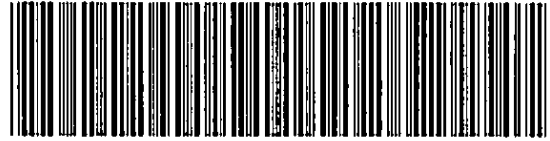

The Corporation shall not be conducted or operated for profit and no part of the net earnings of the Corporation will inure to the benefit of any individual, nor shall any of the profits or assets of the Corporation be used other than for the purposes of the Corporation.


