The undersigned being all of the Directors of this Corporation, submit the Articles of Incorporation thereof in the manner set forth below pursuant to the provisions of Section 617, Florida Statutes (Not-for-Profit).

ARTICLE I

Name and Principal Address

The name of this corporation shall be CONGREGATION SINAI MINNEOLA, INC. and its principal business and mailing address shall be located at 303A North US Highway 27, Minneola, Florida 34715.

ARTICLE II

Purpose

The purposes of this corporation is organized is to provide for the religious needs of the members of the Jewish faith by conducting spiritual and educational programs in South Lake County, Florida.

The organization is organized exclusively for charitable, religious, educational, and/or scientific purposes under section 501(c)(3) of the Internal Revenue Code.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the exempt purposes (charitable, educational, religious and/or scientific). No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publication or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes with the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
