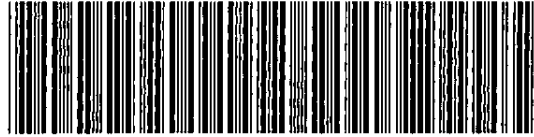

Articles of Incorporation of
PARADISE COAST CHAPTER NINETY-NINES, INC.
(Florida not-for-profit Corporation)

ARTICLE I – NAME

The name of the corporation shall be **PARADISE COAST CHAPTER NINETY-NINES, INC.**

ARTICLE II – PRINCIPAL OFFICE

The principal street address of the corporation shall be 21530 Pearl Street, Alva, FL 33920; and the mailing address shall be PO Box 7042, Fort Myers, FL 33919.

ARTICLE III – PURPOSE
