ARTICLES OF INCORPORATION OF FAMILY CHRISTIAN ACADEMY PARENT TEACHER ORGANIZATION, INC.

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME OF CORPORATION

The name of the corporation, hereinafter referred to as the "Corporation", is Family Christian Academy Parent Teacher Organization, Inc.

ARTICLE II PRINCIPAL OFFICE

The street address of the Corporation's principal office is 15060 Old Cheney Highway, Orlando, FL 32828, and its mailing address is the same.

ARTICLE III PURPOSES

The Corporation is organized exclusively for charitable, religious, or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. Specifically, the purpose of the Corporation is to support the education of children at Family Christian Academy by fostering relationships between the school, parents and teachers. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
