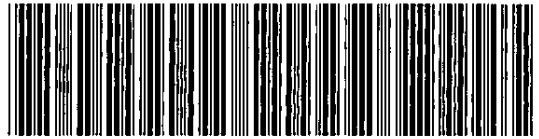

BE CARRIED ON TO INFLUENCE LEGISLATION OR PROPAGANDA.
