**STATEMENT OF FACT**  
**REGARDING FLORIDA CORPORATION HARVARD UNIVERSITY, INC.**


1. I am submitting this Notarized Statement of Fact on behalf of the President and Fellows of Harvard College ("Harvard") to correct fraudulent statements made by an entity registered with the State of Florida Division of Corporations – Harvard University, Inc.
2. The President and Fellows of Harvard College (the "Corporation") is an entity chartered in 1650 that is registered as a charitable corporation with the Commonwealth of Massachusetts. Among other things, the Corporation exercises fiduciary responsibility with regard to Harvard University's academic, financial, physical resources, and intellectual property. In addition to common law trademark rights, Harvard owns hundreds of registrations for the HARVARD Marks throughout the world, including hundreds of registrations in the United States, including registrations for the mark HARVARD UNIVERSITY. See., e.g., Reg. No. 1,578,190.
3. Harvard recently became aware of a corporation registered in the State of Florida using the name Harvard University, Inc. (the "Fraudulent Corporation").
4. The Fraudulent Corporation's corporate filings are rife with false statements that fraudulently suggest a connection to Harvard, including the following statements in its 2023 Annual Report:
  - Listing the Principal Place of Business as President and Fellows of Harvard College, MASSACHUSETTS HALL CAMBRIDGE, MA 02138 USA MASSACHUSETTS HALL CAMBRIDGE, MA 02138 USA. This is not a place of business of the Fraudulent Corporation;

- Identifying Catharine Drew Gilpin Faust as President of the Fraudulent Corporation. President Faust served as president of Harvard from 2007-2018, and has no connection to the Fraudulent Corporation.
- Identifying Steve Hyman, PhD and Barry Bloom – both Harvard faculty members – as officers of the Fraudulent Corporation. They have no connection to the Fraudulent Corporation.

5. The Fraudulent Corporation has no license or permission to use Harvard's registered trademark "Harvard University" in its corporate name. The public should be on notice by this Statement of Fact that Harvard has no connection to or affiliation with the Fraudulent Corporation. Further, Harvard has no connection to or affiliation with, nor has it authorized or sponsored, any goods or services purported to be offered by the Fraudulent Corporation.


The forgoing Statement of Fact is true and correct to the best of my knowledge.
