# Attachment to Articles of Incorporation of Rivers Kids and Youths Foundation Inc.

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code. This Corporation shall be a nonprofit corporation. The specific purpose for which this corporation is organized is a U.S based non-profit organization to support the needy in Rivers State and its community in West Africa, Nigeria. Our mission is to relieve, improve, promote and strengthen the underprivileged that lack basic essentials due to famine, poverty, natural disaster, or poor economy. RKFY will partnership with local schools, churches, people of all faiths, and other organizations to locate families in need by providing them with clothes, food, shoes, school needs, baby supplies food, diapers, clothes, bottles, etc..) and enroll them in a skilled trade.
