Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any applicable Federal Tax Code, or shall be distributed to Federal Government for public purpose. Any such assets not so disposed of shall then be disposed of by a Court of competent jurisdiction of the county in which the principal office of the corporation is located. And the disposal shall be carried out exclusively for such purpose, or to such organizations as the said court shall determine, which are organized and operated exclusively for such purposes.
