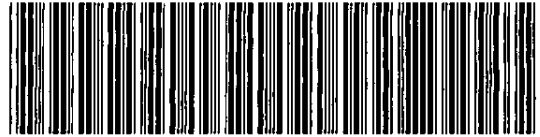

ARTICLES OF INCORPORATION

Article I

The name of this corporation shall be Pinellas Park #4250 Fraternal Order of Eagles Ladies Auxiliary, Inc.

Article II

The principal place of business and mailing address of this corporation shall be:

Article III

This corporation is formed for the purpose of aiding the Fraternal Order of Eagles in carrying out its charitable, humanitarian, patriotic, and other purposes, to which the Fraternal Order of Eagles is dedicated.
