**ARTICLES OF INCORPORATION
FOR "KING'S HOUSE COVENANT FELLOWSHIP INTERNATIONAL, INC."**

ARTICLE III - PURPOSE

SEC. 1 -The church shall hold as it's imperative duty to make known the Gospel of Jesus Christ throughout the entire world, and to teach the Word of God to the end that those who believe may be conformed to the image of Jesus Christ.
