ARTICLED OF INCORPORATION FOR

AMERICAN'S AID TO CHILDREN, INC.

(A Florida Non-Profit Corporation)

Article I, Name

The name of the corporation shall be: AMERICAN'S AID TO CHILDREN, INC.

Article II, Principal Office

The principal street address and mailing address is:

11405 Crestlake Village Drive, Riverview, FL 33569

Article III, Purpose

This corporation is organized exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that also qualify as Section 501(c)(3) exempt organizations. To this end, the purpose of the corporation shall be to provide shelter, clothing, food, and good education to the unfortunate children of India. In accomplishing the coproation will address the physical, dietary and spiritual needs of abandoned and neglected children in India by providing them with meals, clothing, medical treatment, housing, and providing them with the Good News of The Gospel, the hope of a new life and the love they have been searching for.

Article IV, Dissolution

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in § 501(c)(3) of the Internal Revenue Code or corresponding sections of any prior or future law or to the Federal, State, or Local government for exclusive public purpose.

Article V, Manner of Election

The corporation shall have a voting membership, and may have classes of same (if any), as defined in the corporation's bylaws. Pursuant to section 617.0202(d) Florida Statutes, the method of election and selection of directors is as stated in the bylaws. Members shall be elected every two years. The management and affairs of the corporation shall be at all times under the direction of a Board of Directors, whose operations in governing the corporation shall be defined by statute and by the

corporation's by-laws. No member or Director shall have any right, title, or interest in or to any property of the corporation.
