**ARTICLES OF INCORPORATION
OF
WCCM NEPTUNE BEACH CENTER, INC.**

We, the undersigned hereby mutually agree to unite and associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida applicable to corporations not for profit under Section 617.013 of the Florida Statutes, and for this purpose, we hereby make, execute and adopt the following Articles of Incorporation:

ARTICLE I. NAME

The name of this corporation is the **WCCM NEPTUNE BEACH CENTER, INC.**

ARTICLE II. TERM OF EXISTENCE

The term of existence is perpetual. Corporate existence will begin when chartered by the Secretary of State.

ARTICLE III. PURPOSES

The purposes for which the Corporation is organized to operate as a non-profit corporation within the State of Florida with emphasis on meditation as a means to assist in leading life to the full.

No part of the net earnings of the corporation shall inure to the benefit of any member, trustee, director, officer of the corporation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the corporation), and no member, trustee, officer of the corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation.

ARTICLE IV

(B) The territory in which its activities are principally to be conducted is North Florida, United States of America.

The Board of Directors shall not be less three nor more than five members.

ARTICLE V. POWERS

A. This corporation shall have the power to do any and all things necessary or expedient for the accomplishment of the objects and purposes of this corporation, including, but not limited to, the power to acquire and dispose of real and personal property, to enter into contracts and to incur obligations in the name of the corporation, and in general to possess all rights, privileges and immunities, and to enjoy all of the benefits granted to corporations not for profit under the laws of the State of Florida and now enacted or hereafter amended, and in particular, Section 617, Florida Statutes.

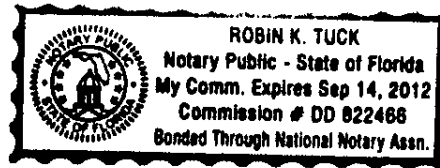

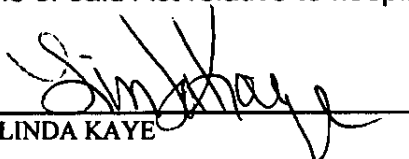
