# Articles of Incorporation of Kingdom Citizens Ministries International, Inc.

A Nonprofit Corporation

Pursuant to the provision of the Nonprofit Corporation Act of this state, the undersigne hereby adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of this Corporation shall be Kingdom Citizens Ministries International Inc.

ARTICLE II

PRINCIPAL OFFICE

The principal place of business of this Corporation shall be 3236 Bodmin Moor Drive Tallahasse, Florida 32317. The mailing address of this Corporation shall be Post Office Box 12396 Tallahassee, Florida 32317-2396.

ARTICLE III

**PURPOSE** 

The purpose for which the Corporation is organized is to teach the Word of God and the message of the Kingdom of God to all the nations to promote a Godly lifestyle and the advancement of the Kingdom of God. In addition, it is our mission is to provide quality events that will touch the hearts and souls of people; to help people rediscover the lost or forgotten Kingdom of God; to reestablish love and self-worth within each individual; to give counsel to other individuals, organizations, and ministries who have a heart to reach God's people; and to impart Godly wisdom and a standard of holiness into people through mentorship and motivational speaking.

Said Corporation is organized exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future Federal tax code.

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document,

the Corporation shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from Federal income tax under section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future Federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future Federal tax code.

Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government, for a public purpose.

Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principle office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

#### ARTICLE IV MANNER OF ELECTION

The manner in which the Board of Directors are elected or appointed is through criminal background checks, character references from three (3) references including one (1) ministerial/pastoral reference, and a desire to transform the lives of God's people.
