# ARTICLES OF AMENDMENT ARTICLES OF INCORPORATION OF CHARGERS BASEBALL BOOSTER, CLUB INC

#### ARTICLE I NAME

The name of this organization shall be Chargers Baseball Booster Club, Inc and will be a Non-Profit organization.

#### ARTICLE II PURPOSE

- A. To promote the welfare of the youth participating in the North Miami Beach Senior High Baseball Team, at home school & community.
- **B.** To promote good sportsmanship, school spirit, leadership, community interest and community service.
- **C.** To secure and use funds for dugouts, concessions, storage area, and other baseball related usuages as deemed so by the Executive Board.
- D. To raise and secure funds to finance the development and equipping the program.
- E. The Booster club is organized exclusively for the charitable, scientific, literary, or educational purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code or corresponding section of any future Federal tax code (hereinafter "Internal Revenue Code").

#### ARTICLE III POLICIES

- **A.** The Booster club shall work with the school to provide proper image and quality enrichment for the youth it serves.
- B. No part of the net earnings or the Booster club shall inure to the benefit of, or

be distributable to its members, directors, officers or other private persons except that the organization shall be authorized and empowered to pay reasonable compensations for services rendered.

#### ARTICLE IV MEMBERSHIP

- A. Membership in this booster club shall be made available to any individual who has substantial interest in and/or ties to a currently participating NMB Baseball player (i.e. parent, guardian, grandparent, teacher, alumni, sponsor, mentor, or etc.) and/or who subscribes to the objects and basic policies of this club without regard to race, color, creed, or national origin, under such rules and regulations not in conflict with the provisions of these bylaws.
- **B.** Only members of the booster club shall be eligible to participate in the business meetings, or to serve in any of its elective or appointive postions.
- **C.** The Chargers Baseball Booster Club shall conduct an annual enrollment of members, but persons may be admitted to membership at any time.
- **D.** Each family (father and mother, or legal guardians) of the booster club shall pay annual dues of \$25.00 to the Chargers Baseball Booster Club.
- E. A membership report will be prepared by the secretary and kept on file annually showing the name and address of the officers and the general membership of the booster club, the amount of dues collected during the period covered, and the number of members of the booster club.

- **F.** The membership shall be valid from the time of enrollment until September 30<sup>th</sup> of the following school year.
- **G.** Each paid member will have one vote for officers or anything that comes before the club.

#### ARTICLE V BOOSTER CLUB MEETINGS

There shall be at least two (2) annual membership meetings. These meetings will be held at a location designated in advance. A special meeting may be called by the booster club upon reasonable notice at any time.

#### ARTICLE VI OFFICERS

- **A.** Each officer of this booster club shall be a member of this club before being eligible to serve as an officer.
- **B.** The officers of this booster club shall consist of a President, Vice President, Secretrary and Treasurer.
- C. Officers shall be elected annually in the month of September of each year.
- **D.** A member whose dues have not been paid prior to the annual election, may not vote in the annual election of officers.

#### ARTICLE VII OFFICERS DUTIES

A. The President shall preside at all meetings of the booster club, shall coordinate the work of the officers, direct goals and budget performance, serve as primary spokesperson for the club, except as otherwise specified and shall have an official signature card on file

with the bank utilized to manage the funds of the club and have electronic access to said accounts.

- **B.** Vice President shall perform all the duties of the President in his/her absence and shall be responsible for annual review of the By-Laws, recommending revisions as deemed appropriate.
- **C.** Secretary shall keep record of all proceedings of the general membership meeting of the club, shall take minutes at all meetings and be kept in a regular bound Secretary's book. A record of the decisions of the booster club shall be kept in a separate book. When a decision is made in meetings a summary of the meeting should go out to the general membership by the Secretary.
- D. Treasurer shall maintain a complete set of books of account in accordance with generally accepted accounting principles and practices, make disbursements from the teams funds and shall pay expenses approved by the board and secure proper vouchers. It shall be the President's responsibility, together with the Treasurer to insure the Chargers Baseball Booster Club's tax return is filed with the IRS by November 15<sup>th</sup> of each year.

#### ARTICLE VIII AMENDING THE BYLAWS

These bylaws may be amended at any regular meeting of the booster club by a vote from its members present and voting, provided the notice of the proposed amendment shall have been given at least 30 days prior to the meeting at which the amendment is voted on. Submission of amendments or revised bylaws for approval by the coach and the booster club will take action promptly to incorporate amendments in its bylaws.
