Attachment to Articles of Incorporation of DOMA Kingdom Alliance, Inc.

AST STEP OF STATE OF

Article III Purposes:

The corporation is organized and shall be operated exclusively for Christian religious charitable and educational purposes including but not limited to organizing, operating and maintaining a Christian association of churches. The Corporation is authorized to accept, hold, administer, invest and disburse for Christian religious, charitable and educational purposes such funds as may from time to time be given to it by any person, persons or corporations, to receive gifts and make financial and other types of contributions and assistance to Christian religious, charitable and educational organizations, and in general, to do all things that may appear necessary and useful in accomplishing the purposes herein above set out. All of the assets and earnings shall be exclusively for the purpose herein above set out, including the payment of expenses incidental thereto. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code."

Article VIII. Additional provisions:

- A. All property shall be irrevocably dedicated to educational, religious and charitable purposes and shall be held in the corporate name of DOMA Kingdom Alliance, Inc.. DOMA Kingdom Alliance, Inc., is a non-profit corporation organized and operated exclusively for educational, religious and charitable purposes, which qualifies for exemption from Federal Income Tax under provisions of Section 501(c)(3) of the Internal Revenue Code. The purchase, sale, lease, mortgage or alienation of said real property shall be transacted according to the By-Laws of the corporation.
- B. In the event of dissolution of this corporation, after payment of all debts, all of the remaining assets of the corporation shall be distributed only to a Christian church which qualifies for exemption from Federal Income Tax under provision of § 501(c)(3) of the Internal Revenue Code as directed by the Board of Directors.
- C. Officers and Directors of the Corporation shall have the right to indemnification to the full extent permitted by law.
- D. Officers and Directors of the Corporation shall be chosen as provided in the bylaws of the Corporation.
 - E. These Articles of Incorporation may be amended as provided in the bylaws.
