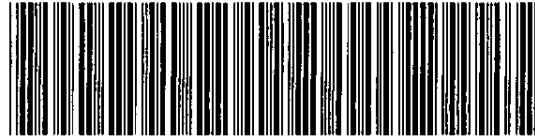

# **ARTICLES OF INCORPORATION**

In Compliance with Chapter 617, F.S., (Not for Profit)

## **ARTICLE I Name**

The name of the corporation shall be:

Paul W. Airey American Legion Post 392 Inc. in the city of Panama City and it shall be hereinafter referred to as the Post.

## **ARTICLE III PURPOSE**

The purpose for which the corporation is organized is:

- To uphold and defend the Constitution of the United States of America
- To maintain law and order
- To foster and perpetuate one hundred percent Americanism
- To preserve the memories and incidents of our associations in the great wars
- To inculcate a sense of individual obligation to the community, state, and nation
- To combat the autocracy of both the classes and the masses
- To make right the master of might

## **ARTICLE IV MANNER OF ELECTION**

The manner in which the directors/officers are elected or appointed:

A Commander, not more than three Vic Commanders designated as First, Second, and Third Vice, Finance Officer, Sergeant-at-Arms, and a Board of Director Committee Chairman shall be elected annually by members of the Post. An Adjutant, Historian, Service Officer, Chaplain, and Public Relations Officer shall be appointed annually by the newly elected Commander with the approval of the Executive Committee.

The election of officers shall be held during a regular General Membership not less than thirty (30) days or more than ninety (90) days prior to the Annual Department Convention. Sufficient written ballots will be prepared in advance by the Adjutant. The Sergeant-at-Arms shall distribute, collect and count the ballots and shall thereafter make the announcement of the results. Only members in good standing in person at the meeting shall be entitled to vote. National and Department headquarters shall be notified of the election of new officers by the Post Adjutant within thirty (30) days after the said elections have been completed.
