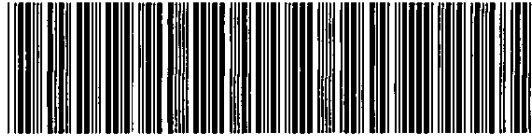

ARTICLE I NAME

The name of the corporation shall be:

DAD'S FOR JUSTICE, INC.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

Dad's For Justice, Inc. is a non-profit community organization with advocacy for children's right to see both parents and grandparents. Parenting is a 50/50 proposition. We are dedicated to helping fathers, (wed or unwed) remain actively involved in the lives of their children. We assist fathers to prepare for Court hearings. All of our services are free of charge to help poor fathers. We realize that many cannot afford court and filing fees. We have skilled, trained, and educated experts in Family Law, Child Custody, Divorce, The Court System, Child Psychology, Child Development, Parenting and Substance Abuse Counseling and Mental Health. We provide pro se kits to enable fathers as a pro se litigant to file their own motions in court. We assist fathers with bus passes, paying for car repairs, and buying required work clothes. We provide also a crisis hotline, individual counseling, informative workshops, seminars, employment services, including job search and training, mediation services to help foster communication between the noncustodial father and mother; and individualized child support payments to reflect both increased earnings and ability to pay. We realize that many fathers owe significant amounts of back support. And for some fathers, especially those whose child support obligations continued to accrue while they were incarcerated, unemployed, or otherwise unable to keep current with their payments, these arrearages present both an insurmountable financial burden and a disincentive to pay current support obligations. To get dads started on paying child support, DFJ will work with The State of Florida Arrears Leveraging Program, which provides for full or partial forgiveness of child support arrearages if a noncustodial parent meets his current support obligations. Fathers that successfully complete our program will be eligible to

participate in the State's Program. We specialize in helping fathers in difficult divorce, custody, visitation and child support battles. We evaluate every case and recommend which of our experts' best meet the fathers' needs to furnish expert opinions in court so that their children come out the winner. We are here to help assuring fathers to know their rights and their children rights to have a father, and also that the court system does not commit a fathersectomy and cut them out of their children's lives.

In order to ease the transition into the workforce, Dad's for Justice, Inc is the first to offer a long term monitoring and support, which gives noncustodial fathers a safety net. Once leaving the program, participants are monitored and given access to Dad's for Justice, Inc's support services for up to 5 years. This continuous support ensures that participants remain on the right track to responsible fatherhood.

The activities and services of Dad's for Justice, Inc. are available to all residents of the communities in which it serves without regard for income, race, color, national origin or handicap of the participants.

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501C(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III thereof. No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501C (3) of the Internal Revenue Code, or the corresponding section of any future tax code, or (b) by a corporation, contributions to which are deductible under section 170C (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501C(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


