Pursuant to the provisions of section 617.1006, Florida Statutes, this *Florida Not For Profit Corporation* adopts the following amendments to its Articles of Incorporation.

1. The name of the corporation is: Fairway Community Church, Inc.
2. The following amendments were adopted
 - a. Fairway Community Church, Inc. is organized exclusively for charitable, religious, educational and/or scientific purposes including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c) 3 of the Internal Revenue Service Code, or corresponding section of any future federal code.
 - b. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article "a" hereof.
 - c. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
4. The foregoing Amendments were adopted by the corporation on 5/4/2016.
5. The adoption of the amendments was duly approved by the board of directors by a vote of at least two-thirds of the directors in office. Members are not entitled to vote on the amendments to the Articles of Incorporation.
