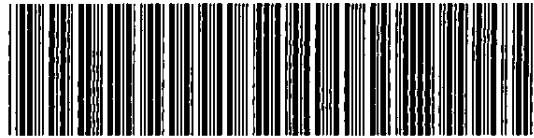

ARTICLES OF INCORPORATION

Of

I.

The name of the corporation shall be Aeiresstoddle Community Charter Schools, Inc.

II.

The principal place of business of this corporation shall be 13181 NW 45th Drive, Miramar, Florida 33027.

III.

This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The specific purpose of the corporation is to establish, manage, operate, guide, direct and promote Aeiresstoddle Community Charter Schools, and such other educational activities as the Board of Directors may define from time to time.

IV.

Directors are appointed based on their expertise in education, commitment to public service, business experience and financial management skills.

V.

Notwithstanding any other provisions of these Articles of Incorporation, the corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Internal Revenue Code Section 501(c)3 or (2) by a corporation, the contributions to which are deductible under Internal Revenue Code Section 170(c)(2).

IX.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.




