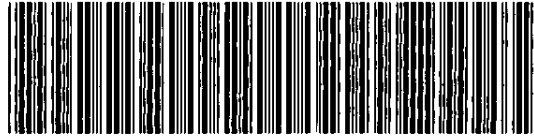

ARTICLE III PURPOSE

This corporation is organized and operated exclusively to support and enhance general public awareness of charitable, religious, educational, literary, humane and/or scientific purposes, including, for such purposes, but not limited to participation and the making of distributions to organizations that qualify as exempt organizations under Section 501©(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.


No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(e)(2) of the Internal Revenue Code.


The property of this corporation is irrevocably dedicated to support and enhance general public awareness of charitable, religious, educational, literary, humane and/or scientific purposes. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for the purpose to support and enhance general public awareness of charitable, religious, educational, literary, humane and/or scientific purposes and which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code.
