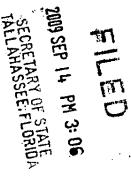

ARTICLE IV MANNER OF ELECTION

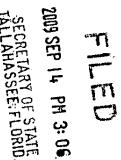
The manner in which the directors are elected or appointed:
