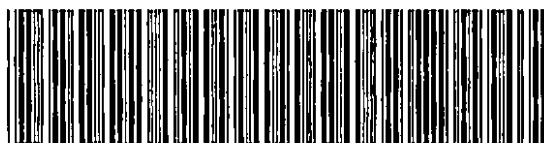

I would like to add a purpose and dissolution clause.  
The below purpose can replace the one listed in Article III: "Said organization is organized exclusively for charitable, religious, educational, and scientific purposes including for such purposes, the making distributions to organizations that qualify as exempt organizations described under section 501(c)(3) of the internal revenue code. or corresponding section of any future federal tax code."

I would like to add the dissolution clause:  
"upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the internal revenue code, or corresponding section of any future federal tax code. Or shall be distributed to the federal government or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes."
