I am writing you this letter to indicate that GoDonGo.com, LLC, is voluntarily dissolving as it was an error in filing. We needed to file as a non-profit corporation. As the managing principal in GoDonGo. Com, LLC, I will not revoke the voluntary dissolution of the LLC and will release the name so it can be obtained by another entity (which of course will be us).
