ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected and appointed:

Officers 1

Section 1. The officers shall be elected by Director and CEO of the organization, "Officers must meet the qualifications" in these Bylaws. Officers shall be elected for a one year terms of office. Officers may serve a second term if elected, or more consecutive term, if elected, but no more than 3 years. Founder/Trustee C E O shall hold lifetime. Board- Directors shall hold 3 years or longer, ACCEL International counsel Governor shall hold 3 years or longer, ACCEL Nationwide Counsel Governor shall hold 3 years or longer, ACCEL Education Counsel/Affair Specialist shall hold three (3) years term, Christian Counseling TV Director shall hold three (3) years term, Christian Counseling TV Counsel/Affair Specialist shall hold three (3) years term, Christian Counseling TV Coordinator Specialist Officer shall hold three (3) years term, and Fund Development Specialist shall hold three (3) years term.

- a) All officers shall serve without compensation. No elected officer shall accept any remuneration. No elected officer shall accept any remunerative employment from Alpha Christian Counseling Services of Palm Coast Inc. or any DBA organizations of Alpha. Except the educators, trainers or counselors and including convention speakers. Employees will be selected by the board to care on the project and mission.
- b) The Board of trustees shall appoint and determine the salary of the educators, trainers, mentors, counselors or convention speakers or other position to care on the organization. The board of trustees shall have the power to appoint and determine the compensation of such other administrative officers as in its judgment may be necessary.
- c) ACCEL Network New organization/associations all Student must bestow previously a registry fee of \$25.00 dollars and required a selected ACCEL books.
- d) All mentors shall serve until their successors year elected and qualified.

- e) Officer/Director decide to step-out before the designated time, organization takes disciplinary action against the officer/director a penalty fee of fifty dollars (\$50.00) will be charge to "remove from the Board of Director or officer position".
- f) A vacancy occurring in any elective office shall be filled in the manner prescribed in these Bylaws.
- g) In the event that a director/officer with a remaining term in office of one (1) year seeks to be elected to an director/office above the level of Trustee, the term of office of said Trustee shall end on October 30th following the annual National or International convention at which the Trustee seeks higher office.
- h) In the event of Dr. Maria Pinto Barbosa death, Alpha Christian Counseling Services of Palm Coast Inc and all DBA Directors/Officers and Patrick Domingues and Carlos Manuel Pinto together they will elect a qualified officer to occupy Dr. Maria Pinto position.
