Articles of Incorporation of Comets Swim Team Alumni Association, Inc.

First – Name

The name of the Corporation shall be Comets Swim Team Alumni Association, Inc.

Second – Principal Location

The place in this state where the principal office of the Corporation is to be located is the City of Pembroke Pines, Broward County. The principal street address shall be 17189 Sheridan St., Pembroke Pines, FL, 33029. The principal mailing address shall be 11100 NW 17th Ct., Pembroke Pines, FL, 33026.

Third - Purpose

Comets Swim Team Alumni Association is organized exclusively for charitable purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The Association will be organized and operated primarily to support and develop amateur athletes who are members of the Comets Swim Team or Anderson Aquatics, LLC for national or international sports competition.

Fourth – Initial Directors and Officers

The names and addresses of the persons who are the initial trustees of the corporation are as follows:

Robyn Goldman - President

Kristen Lunak – Treasurer - 11100 NW 17th Ct., Pembroke Pines, FL, 33026

Michelle Vargas – Vice President/Secretary

Officers shall be appointed every two years. The appointment shall be made by current officers and requires a majority vote (2 to 3) to be effective.

Fifth – Use of Earnings

No part of the net earnings of the Comets Swim Team Alumni Association, Inc., shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not

permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Sixth – Dissolution Clause

Upon the dissolution of the Comets Swim Team Alumni Association, Inc., assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

Seventh – Initial Registered Agent/ Incorporator

The Registered Agent shall be Kristen Lunak located at 11100 NW 17th Ct., Pembroke Pines, FL, 33026. The incorporator shall be designated the same as the registered agent.

MANNER OF ELECTION

The manner in which the directors are elected or appointed:

Directors of the Comets Swim Team Alumni Association, Inc. shall be appointed by every two (2) years by the current directors, beginning with the appointment of the initial officers listed below. Officers may serve multiple terms and appointment shall be ratified by a majority vote of current officers.
