

ARTICLES OF INCORPORATION OF COMPASS – MONEY GOD'S WAY, INC. A FLORIDA NONPROFIT CORPORATION

The undersigned, acting as the incorporator of COMPASS - MONBY GOD'S WAY, INC. ("Corporation"), does hereby adopt the following Articles of Incorporation pursuant to the Florida Not For Profit Corporation Act, Chapter 617, Florida Statutes:

ARTICLE I NAME OF CORPORATION, MAILING ADDRESS AND ADDRESS OF PRINCIPAL OFFICE

The name of this Corporation shall be the COMPASS – MONEY GOD'S WAY, INC. The mailing address of the corporation is 100 Crown Oak Centre Drive, Longwood, Florida 32750, and its principal office shall be located at 100 Crown Oak Centre Drive, Longwood, Florida 32750,

ARTICLE II REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this Corporation shall be 450 South Orange Avenue, 14th Floor, Orlando, Florida 32801 and the name of the initial registered agent for the Corporation shall be Timothy J. Manor.

ARTICLE III PURPOSES

Section 1. The specific and primary purposes for which this corporation is formed are: (i) teaching people the Gospel of Jesus Christ and God's way of handing money as revealed in the Bible, and (ii) assisting other charitable organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, as amended (the "Code"), or the corresponding provisions of any future tex laws; (iii) seeking support by soliciting, receiving and administering

and taking and holding, absolutely or in trust, for any of such purposes funds and property of every kind, real, personal, tangible and intemgible, subject only to any limitations and conditions imposed by law or by the instrument under which received; to sell, lease, convey or otherwise dispose of any such property and to invest and reinvest the proceeds of and earnings from such property in accordance with investment policies established from time to time by the

powers, which a corporation not for authorized to exercise.

<u>Section 2.</u> The general purposes for which this corporation is organized are exclusively charitable purposes within the meaning of the Code or the corresponding provisions of any future federal tax laws.

Section 3. Notwithstanding any other provision of these articles, this corporation shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under the Code, or the corresponding provisions of any future federal tax laws.

Section 4. In the event this corporation is in any year determined to be a "private foundation" as defined in Section 509(a) of the Code it shall:

- Distribute its income for each tax year at such time and in such manner so that it (a) will not become subject to the tax on undistributed income imposed by Section 4942 of the Code, or the corresponding provisions of any future federal tax laws.
- Not engage in any act of self-dealing as defined in Section 4941(d) of the Code. or the corresponding provisions of any future federal tax laws.
- Not retain any excess business holdings as defined in Section 4943(c) of the (c) Code, or the corresponding provisions of any future federal tax laws.
- Not make any tazable investments as defined in Section 4944 of the Code, or the corresponding provisions of any future federal tax laws.
- Not make any taxable expenditures as defined in Section 4945(d) of the Code, or (e) the corresponding provisions of any future federal tax laws.

ARTICLE IV

This corporation shall be authorized to exercise the powers parmitted corporations not for profit under Chapter 617, Florida Statutes; provided, however, that this Corporation, in exercising any one or more of such powers, shall do so in furtherance of the exempt purposes for which it has been organized within the meaning of Section 501(c)(3) of the Code.

ARTICLE V NO MEMBERSHIP

The corporation shall not have any members.

ARTICLE VI TERM

This corporation shall have perpetual existence unless sooner dissolved according to law.

The Corporation shall indemnify any person who was or is a party, or is threatened to be made a party, to any firestened, pending or contemplated action, suit or proceeding, whether civil, criminal, administrative or investigative by reason of the fact that he is or was a director, employee, officer or agent of the Corporation, against expenses (including attorney's fees and appellate attorney's fees), judgments, fines and amounts paid in settlement actually and reasonably incurred by him in connection with the action, suit or proceeding if he acted in good faith and in a manner he reasonably believed to be in, or not opposed to, the best interest of the Corporation; and with respect to any criminal action or proceeding, if he had no reasonable cause to believe his conduct was unlawful; except that no indemnification shall be made in respect to any claim, issue or matter as to which such person shall have been adjudged to be liable for gross negligence or willful misfeasance or malfeasance in the performance of his duty to the Corporation, unless and only to the extent that the court in which the action or suit was brought shall determine, upon application, that despite the adjudication of liability, but in view of all the circumstances of the case, such person is fairly and reasonably entitled to indemnity for such expenses that the court shall deem proper.
