ARTICLES OF INCORPORATION FOR ADAGIO GUARDIANSHIP ADVOCATES, INC. A NOT FOR PROFIT CORPORATION

The undersigned incorporator to these Articles of Incorporation hereby forms a corporation by and under the laws of the State of Florida providing for the formation, rights, liabilities, privileges and immunities of a not for profit corporation subject to Florida Statutes Chapter 617.

ARTICLE I NAME

The name of the Corporation shall be Adagio Guardianship Advocates, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this Corporation shall be 4501 Manatee Avenue West, #228, Bradenton, FL 34209.

ARTICLE III PURPOSE AND POWERS

This Corporation is organized exclusively for charitable and educational purposes under Section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, and to permanently dedicate its assets to exempt purposes.

- Section 1: Adagio Guardianship Advocates, Inc. is organized as a not for profit corporation formed to provide direct client services, information and resources to individuals for the care and support of the frail, elderly, mentally or physically disabled, and/or at risk population of Florida. Direct services include, but are not limited to; care management, financial management, information and referral; and services as a guardian, fiduciary or trustee. Services shall be provided to individuals on a sliding scale basis.
- Section 2: To the extent permitted by Code Section 501(c) (3), the Corporation is organized exclusively for one of more of the following purposes: religious, charitable, scientific, and testing for public safety, literary or educational purposes, or to foster national or international amateur sports competition, or for the prevention of cruelty to children or animals. All references to "Code" are to the Internal Revenue Code of 1986 as amended or to corresponding provision of future federal tax legislation.
- Section 3: The Corporation may exercise all powers, rights and privileges conferred on not for profit corporations pursuant to the laws of the State of Florida.

ARTICLE IV LIMITATIONS- CHARITABLE STATUS

Section 1: No part of the net earnings of the Corporation shall inure to the benefit of (or be distributable to) its directors, officers, members or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of any of its purposes. No substantial part of the activities of

the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, except as otherwise provided in Code Section 501(h): The Corporation shall not participate or intervene in any political campaign (including the publishing or distributing of statements) on behalf of any candidate for public office. Notwithstanding any other provision of these Articles of Incorporation, the corporation shall not carry on any activities except those permitted to be carried on by a corporation exempt from federal income tax under Code Section 501(c)(3) or by corporation contributions to which are deductible under Code Section 170(c)(2).

Section 2: The Corporation shall not operate for the primary purpose of conducting a trade or business not related to its exempt purpose, nor have an illegal purpose or activity, or in violation of fundamental public policy.

Section 3: If the Corporation is at any time deemed to be a private foundation within the meaning of Code 509(a), then for the period in which the Corporation is so deemed, the Corporation shall distribute its income for each tax year at such time and in such manner as not to subject the Corporation to tax under Code Section 4942, and the Corporation shall not engage in any act of self dealing as defined in Code Section 4941(d), retain any excess business holdings as defined in Code Section 4944 or make any taxable expenditures as defined in Code Section 4945(d).

ARTICLE V NON DISCRIMINATION POLICY

Adagio Guardianship Advocates, Inc. has a racially nondiscriminatory policy towards its clients and does not discriminate on the basis of race, color, sexual orientation, national, ethnic or religious origin in administration of its policies, or acceptance of wards as clients.


