ARTICLE III
NATURE OF CORPORATION

In stating the following beliefs it must be noted that we will find our unity in this Network not primarily on the basis of doctrinal agreement, but upon agreement regarding the following values: salvation is by grace through faith in the death and resurrection of Jesus; we must evangelize the lost, especially by planting and strengthening churches; ministering to the poor, especially the orphans and widows; avoiding hypocrisy, pride, and paternalistic attitudes in our ministry to others; and we are to love the whole body of Christ. In this day we can not inflict wounds upon the body of Christ but rather must encourage one another. We must shift the conflict from the internal denominational differences in order to conserve our strength to present a united in the Spirit perspective of Christianity to the Hindu, Buddhist, Islamic, New Age, Shintoist, and Secular Humanist religions which stand against the claims of our Lord Jesus the Christ.

For these reasons we have stated our doctrinal beliefs, not as a litmus test that must be passed in order to be a part of the network, but for a basis of understanding of the views of the founder of the Network, Hurley Russ. The unity we have must be in the Spirit and in our common commitment to share the gospel in its fullness, in order to see people saved and incorporated into a local church. (The fullness of our gospel includes forgiveness, healing, deliverance, and the second coming of our Lord to consummate His Kingdom upon this earth.) The people in the churches are to cooperate with the Holy Spirit to care for the poor, orphans, and widows. We exist to work together to work with apostolic leaders around the world who are planting churches, and ministering to the poor, orphans, and widows in the power of the Holy Spirit.

The additional purpose of this corporation shall be to train, educate and license ministers, preachers and church leaders, and to establish, maintain and conduct schools for the religious instruction of people of all ages, pursuant to and according to the laws and the status of the State of Florida
