## Articles of Incorporation

Know All Men By These Presents:

That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a not-for-profit corporation under the laws of the State of Florida, and to that end do hereby adopt articles of incorporations as follows:

### Article I

The name of this corporation shall be: **Florida Primary Care Coalition, Inc.**

### Article II

The principal street address and mailing address is:

### Article III

The period of duration of this corporation is perpetual.

### Article IV

The purposes for which this corporation is organized shall be:

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986 and to that end, the Corporation is empowered to hold any property, or any undivided interest therein, without limitation as to amount or value; to dispose of any such property and to invest, reinvest, or deal with the principal or the income in such manner as, in the judgment of the directors, will best promote the purposes of the Corporation, without limitation, except such limitations, if any as may be contained in the instrument under which such property is received, these Articles of Incorporation, the By-Laws of the Corporation, or any applicable laws, to do any other act of thing incidental to or connected with the foregoing purposes or in advancement thereof, but not for the pecuniary profit of financial gain of its directors or officers except as permitted under the Not-for Profit.

No part of the net earnings of the Corporation shall inure to the benefit of any member, trustee, officer of the Corporation, or any private individual, except that reasonable compensation may be paid for services rendered to or for the Corporation affecting one or more of its purposes, and no member, trustee, officer of the Corporation, or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Corporation

Upon the dissolution of the Corporation or the winding up of its affairs, the assets of the Corporation shall be distributed exclusively to one or more charitable, religious, scientific, testing for public safety literary, or educational organizations which would then qualify under the provisions of Section 501 (c)(3) of the Internal Revenue Code and its regulations as they now exist or as they may be hereafter amended, or to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Courts of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organizations or organizations as said Court shall determine which are organized and operated exclusively for such purposes. The specific goals of this corporation will be to:

1. Promote public policies that pave the way to high-quality health care services that are efficiently delivered
2. Work in partnership with government, business, finance, philanthropy, healthcare providers and a wide variety of other organizations committed to the health care needs of Florida communities
3. To assist primary care organizations with finding resources to expend and construct facilities to increase the access to primary care
4. Said corporation is organized exclusively for charitable, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code
5. To expand and enhance primary and preventive health care in underserved communities
6. Deliver programs that enable health care organizations to develop state-of the art facilities and adopt the best primary and preventive care practices

#### **Article V**

The directors of the corporation shall be elected in accordance with methods and qualifications specified in the bylaws of the Corporation. In no event shall the number of directors be fewer than three.

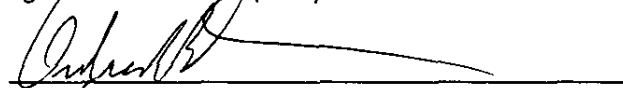

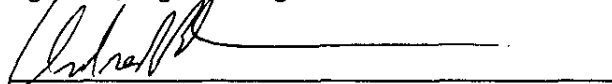
