ARTICLES OF INCORPORATION
OF

SECRETARY OF STATE

PRINCIPAL INVESTIGATORS ASSOCIATION, INC.
(a corporation not for profit)

THE UNDERSIGNED, acting as sole incorporator of a corporation not for profit to be formed under the Florida Not for Profit Corporation Act, adopts the following Articles of Incorporation:

FIRST: The name of the corporation (the "Corporation") is:

PRINCIPAL INVESTIGATORS ASSOCIATION, INC.

SECOND: The initial principal office and mailing address of the Corporation is:

4301 Gulfshore Boulevard N., Suite 1404
Naples, FL 34103

THIRD: The term for which the Corporation is to exist shall be perpetual or until such time as the Corporation shall have been dissolved in accordance with the laws of the State of Florida.

FOURTH: The Corporation is organized for the purpose of engaging in any lawful act or activity for which corporations not for profit may be formed under the Florida Not for Profit Corporation Act; provided, however, that the organization shall not participate in, or intervene in (including the publishing or distribution of statements for) any partisan political campaign on behalf of any candidate for public office.


