## ARTICLES OF INCORPORATION OF New Kings Manor, Inc

The undersigned acting as incorporators of a corporation pursuant to Florida Corporation Law Statute 617, adopts the following Articles of incorporation.

### ARTICLE I NAME

The name of the corporation shall be:

#### ARTICLE II PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

## ARTICLE III PURPOSES

"However" if the named recipient is not in existence as a distributee, or unwilling to accept the distribution, the assets shall be distributed to a fund, or foundation, or organization which is operates exclusively for purposes specified in section 501 (c)(3) of the Internal Revenue Code of 1986 or any corresponding provision of any future Internal Revenue Law.

#### ARTICLE V LIMITATION OF POWERS

Not withstanding any other provision of these articles, the organization shall not carry on any activities not permitted to be carried on by an organization Exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code of 1986 or any corresponding provision of any future Internal Revenue Law.
